RSC IX RESOLUTION NO. 05 Series of 2023

ENJOINING DATA SOURCES/AGENCIES TO SUPPORT THE PHILIPPINE STATISTICS AUTHORITY IX
FOR THE DATA REQUIREMENTS IN THE ESTIMATION AND PREPARATION OF THE 2018-2022
PROVINCIAL/CITY PRODUCT ACCOUNTS AND ENDORSING THE SAME TO THE REGIONAL
DEVELOPMENT COUNCIL IX FOR APPROPRIATE ACTION

WHEREAS, Philippine Statistics Authority (PSA) is the primary statistical agency of the government tasked to compile and maintain macroeconomic accounts and indicators at the national and sub-national levels as well as develop and maintain appropriate frameworks for the improvement of statistical coordination across the country;

WHEREAS, PSA also maintains the System of National Accounts which contains the frameworks that measure the economic performance of the country down to the regional level, namely: Gross Regional Domestic Product (GRDP) and Gross Regional Domestic Expenditure (GRDE);

whereas, in 2021, PSA started the Provincial Product Accounts (PPA) rollout. PPA serves as a means to derive the Gross Domestic Product of the provinces and highly urbanized cities (HUCs) to provide a suitable measure of economic performance at the provincial level and as a source of indicator to monitor the economic development or progress at the local level. MIMAROPA, Region X and Region VII were the pilot regions in the country;

WHEREAS, in 2022, PSA expanded the compilation of PPA to nine regions, namely: Cordillera Administrative Region, CALABARZON, MIMAROPA, Western Visayas, Central Visayas, Eastern Visayas, Northern Mindanao, Davao Region and SOCCSKSARGEN;

WHEREAS, in 2023, PSA expands the compilation of PPA to the rest of the regions including the Zamboanga Peninsula. The PPA includes the compilation of Gross Domestic Product (GDP) of the provinces and HUCs for the period of 2018 to 2022;

WHEREAS, PSA IX will conduct workshops and consultations with the regional and provincial stakeholders, training and capacity-building activities, estimation, validation workshops, field visits, and dissemination for the compilation of the PPA;

NOW, THEREFORE, on motion by Dr. Mewchun WS. Pamaran, Regional Director of Philippine Statistics Authority IX duly seconded by Ms. Maria Marjorie J. Pascual, Administrative Officer IV of Department of Trade and Industry IX, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that RSC IX enjoins the members of the Regional Statistics Committee IX and other data source agencies to support the Philippine Statistics Authority for the Data Requirements in the Estimation and Preparation of the 2018-2022 Provincial/City Product Accounts.

RESOLVED FINALLY, that all stakeholders be provided with a copy of this resolution for their information.
