The 2023 Updating of the List of Establishments (ULE) with its rider, the 2022 Census of Agriculture and Fisheries (CAF) for Non-Households is a nationwide activity. The 2023 Updating of the List of Establishments (ULE) aims to update the establishments already listed in 2022 Preliminary List of Establishments and to determine establishments engaged in Agricultural and Fishery activities or the non-households units and to capture new units. Some of the uses of the data results in 2023 Updating of the List of Establishments (ULE) is to provide statistical frame for the conduct of establishment/enterprise censuses and surveys. It is also use to compile micro, small and medium enterprises (MSMEs) statistics and the basis for the classification of barangay into urban/rural area and the creation of barangay into city or municipality and province.
